DECLARATION OF PUBLIC HEALTH EMERGENCY


WHEREAS, the City of George West on the 15th day of March, 2020 is facing the possible threat of widespread cases of the Corona Virus COVID-19, and

WHEREAS, I, Andrew Garza, the Mayor of the City of George West, has determined that extraordinary measures must be taken to ensure the safety, promote the health and well-being of people and to protect the Citizen's of George West,

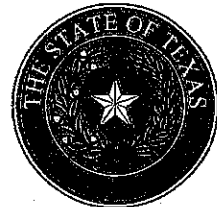
NOW, THEREFORE, BE IT PROCLAIMED BY THE MAYOR, ANDREW GARZA, OF THE CITY OF GEORGE WEST, TEXAS:

1. That a local State of Emergency is hereby declared for the City of George West pursuant to Chapter 418 of the Texas Government Code.
2. Pursuant to Chapter 418 of the Government Code, the state of emergency shall continue for a period of not more than thirty (30) days from the date of this declaration unless continued or renewed by the City Council or Mayor of the City of George West.
3. Pursuant to Chapter 418 of the Government Code, this declaration of a local state of emergency shall be given prompt and general publicity and shall be filed promptly with the City Secretary.
4. Pursuant to Chapter 418 of the Government Code, this declaration of a local state of emergency activates the emergency management plan as adopted by the City of George West through the interjurisdictional agreement between the City of George West and Live Oak County.
5. That this proclamation shall take effect immediately from and after its issuance.


