2. NO PARKING INSIDE PARK AREA.
3. PARK CLOSES AT 10:00 P.M.
4. NO LOUD MUSIC.
5. NO ALCOHOLIC BEVERAGES ALLOWED ON CITY PROPERTY.
6. FIRES ARE TO BE STARTED IN FIRE BOX OR BBQ PITS ONLY.
7. CLEAN UP LITTER AND REMOVE ANY OBJECTS OR DECORATIONS ON PAVILION BY YOUR SCHEDULED TIME FOR COURTESY OF THE NEXT SCHEDULED EVENT.
8. THE CITY OF GEORGE WEST EMPLOYEE WILL TURN ON THE ELECTRICITY BEFORE THE SCHEDULED EVENT AND WILL TURN OFF THE ELECTRICITY AFTER THE SCHEDULED EVENT. IF FOR SOME REASON THE ELECTRICITY IS NOT TURNED ON, PLEASE CALL THE SHERIFF'S OFFICE AT (361)449-2271 AND EMPLOYEE ON CALL WILL TURN IT ON.
9. CITY REQUIRES 48 HOUR CANCELLATION NOTICE.
10. DEPOSIT WILL BE REFUNDED IF NONE OF THE RULES ARE BROKEN, NO DAMAGES ARE DONE, AND EMPLOYEE INSPECTION OF CONDITION OF PARK IS SATISFACTORY.

INDEMNITY

Renter (or Lessee, depending on what the lease calls the person renting), its officers, directors, employees, agents and other representatives agree to indemnify and hold harmless the City of George West and its officers, directors, agents, employees and representative from and against all liability for any and all claims, lawsuits, demands, and/or actions arising from or based upon any acts or omissions intentional, reckless, negligent or otherwise on the part of Renter (or Lessee) its officers, directors, employees, agents, members, visitors, contractors, subcontractors or other persons which may arise out of our result from Renter's (or Lessee's) occupancy or use of the facilities and/or activities conducted in connection with or incidental to this agreement. Renter (or Lessee) shall also indemnify the City of George West, its officers, directors, agents, representatives and employees against any and all liens imposed upon the facilities arising as a result of Renter's conduct or activities. This indemnity shall apply regardless of the nature of the injury, harm or damage alleged, whether for injury or death to persons or damage to property and whether the claims are alleged as common law, statutory or constitutional claims or otherwise. This indemnity provision shall apply whether the basis for claims, lawsuit, demand and/or action is alleged to be attributable in whole or in part to Renter or any of its representative.

IF ANY OF THE RULES ARE BROKEN OR THE PARK IS NOT IN SATISFACTORY CONDITION, YOU WILL FORFEIT YOUR DEPOSIT. I HAVE READ THE ABOVE STATED RULES & AGREE TO ABIDE BY THESE RULES.
