GEORGE WEST CITY POOL RESERVATION RULES & REGULATIONS

1. Pool Parties are from 6:00 p.m. to 8:00 p.m.
2. The City of George West is not responsible for any accidents or lost articles.
3. Parties must be supervised by an adult.
4. Everyone must respect the lifeguards on duty and obey all pool rules.
5. No alcoholic beverages or smoking allowed on premises.
6. No handguns allowed on City property or premises.
7. No glass containers, food or drinks allowed in pool.
8. No diving.
9. No running, wrestling, pushing or profanity.
10. Person reserving the pool is responsible for any damages caused to premises.
11. Person reserving the pool must have the pool area cleaned and everyone must leave by 8:00 p.m. or an additional fee will be charged.
12. Deposits will be refunded if no Rules and Regulations are violated. If the amount of people exceeds the amount paid for, the additional fee will be deducted from the deposit. Deposits can be picked up only by the person that reserved the pool at City Hall the next business day.
13. There is a 72-hour cancellation notice required or the deposit will be forfeited.

Up to 80 people (4 lifeguards)	\$150.00 + \$50.00 Refundable Deposit

INDEMNITY

Renter (or Lessee, depending on what the lease calls the person renting), its officers, directors, employees, agents and other representatives agree to indemnify and hold harmless the City of George West and its officers, directors, agents, employees and representative from and against all liability for any and all claims, lawsuits, demands, and/or actions arising from or based upon any acts or omissions intentional, reckless, negligent or otherwise on the part of Renter (or Lessee) its officers, directors, employees, agents, members, visitors, contractors, subcontractors or other persons which may arise out of our result from Renter's (or Lessee's) occupancy or use of the facilities and/or activities conducted in connection with or incidental to this agreement. Renter (or Lessee) shall also indemnify the City of George West, its officers, directors, agents, representatives and employees against any and all liens imposed upon the facilities arising as a result of Renter's conduct or activities. This indemnity shall apply regardless of the nature of the injury, harm or damage alleged, whether for injury or death to persons or damage to property and whether the claims are alleged as common law, statutory or constitutional claims or otherwise. This indemnity provision shall apply whether the basis for claims, lawsuit, demand and/or action is alleged to be attributable in whole or in part to Renter or any of its representative.
