First applicant: Robert Allen McGinnis

Mr. McGinnis addressed the council

Married has two daughters, has been in law enforcement for 27 years. Born in Kentucky, Dad was transferred to South Texas when he was in 2nd grade.

Mayor Garza explained that each councilmember will ask him 3 questions, core questions. These are

the same question asked to all applicants. After that they will looked at his resume and if there are any questions pertain to his resume (educational questions, experience question) will be asked at that time.

"we got to have a very well train police department." Mr. McGinnis stated that his goal is to address the problems that exist and to improve the quality of life. Second Applicant: David Perkins

Mr. Perkins has been a Police Officer for a little over 30 years, Mr. Perkins begun his law enforcement career at 18 yrs. of age. He is the second generation police officer, his Dad was Chief of Police in Port Aransas. Mr. Perkins currently works as assistant Chief of Police Aransas Pass Police Department. He is in charge of the operations of every division in the department.

Mayor Garza, explained to Mr. Perkins that each councilmember gave three questions to the City Secretary. None of them has seen the question and there will be some repetition, each question shall be asked to each applicant coming before the council.

Each councilmember asked their questions and Mr. Perkins answered, and at times he elaborated giving examples about the topic.
