## Special Session City Council Meeting Minutes - August 25, 2018

- I. The City Council met in Special Session with Mayor Andrew Garza calling the meeting to order.

### **BUSINESS:**

1. Applicants for Public Works Director, will be interviewed by the City Council in a question and answer format conducted in an Open Session. Each applicant will end their interview by briefly addressing the citizens of George West. (There will be no public participation.)

First applicant: John Rodriguez

Explained that with the experience he has he would be the best fit for the City of George West.

### **Budget Workshop**

a. Discussion on the Fiscal Year October 1,2018 to September 30,2019 budget. (In conjunction with the Open Meetings Act, there will be NO Citizen Participation during the workshop.)

Georgia Vines wants to know where the council stands on property tax. Georgia, wants to go down on taxes, with revenue staying the same. We have an extra sales tax that was voted on in the 70's that allows the city to keep it's property taxes fairly low. Mr. Wilson, thinks we are working backwards. Wants to know if we raise the taxes where are we going to spend the money. Wants to know each departments budget, and who is going to get pay raises, before we decide to set a tax rate. Ms. Vines explains that the rollback rate is .054219. There is a very fine line between the rollback rate, and the city's tax rate. Mayor asked Chief Perkins, how they figured this out at his previous job. Chief Perkins, says they would start it with the budget, but he could not explain in detail how they figured out all of the numbers. School taxes are going to raise, due to not getting grants that they were anticipating. Pat Clifton, wants to know why we are not working on the budget sooner? Pat Clifton, says they need to be informed to make sure we are all covered. Next year they would like to start the budget sooner. Ms. Vines stated that she started the budget back in April, but she could not access some of the financial reports she needed in a timely manner. Mayor says we have certain deadlines to meet, we cannot go any further with budget until we decide on a tax rate. Mr. Wilson, wants to have every departments budget in sooner in the coming year, so they city is not in the same position. Ms. Wasicek, explains that it has been a crazy year and people have rolled through this place. Ms. Vines, explains what they would generate if they raised the taxes. Mr. Wilson, wants to make it clear that we are NOT lowering taxes, just the tax rate. Mr. Wilson would like a date to put on the next agenda when each department has to complete their budget.
