Item #2 Consideration and Action to change the time of the February, City Council Regular Session Meeting to 6:30 p.m. Council Member Kitley Wasicek moved to change the time back to 7:00 p.m. Seconded by Mayor Andrew Garza. Open for discussion. Mayor Garza called for a vote. All opposed. Item fails. The meeting next month will be at 7:00 p.m.

PRESENTATIONS:

4. Engineer's Report by LNV

The possible variance was denied by TCEQ, they have the option to go to Austin, and sit with the TCEQ to explain to them what's at stake. They approved the proposal for the headworks, it will cost about \$135,000 if the city moves forward with automatic bar screen. Option number two move forward with liner which would cost \$240,000, but talking with Mr. Higgins, he would like to move forward with the headworks. There are a lot of similar plants around the area that do not have ponds to use, and they seem to make it work. Mayor suggested to buy bar rake at \$94,000, and find a contractor to do the labor separate. A purchase over \$50,000, according to the Fair Bids Act, must go out for bids. Mr. Ysassi, explained how he would feel more comfortable if the job was bid out. Grady, feels this brand of bar screen is less problematic, they are getting installed in places similar to our city. LNV, puts requirements together before it sends out bids. The requirements they put together help prevent the city from getting something that is not going to last. They will have bids ready before the next council meeting. Mr. Higgins thinks that TCEQ, is just tired of dealing with the city, because we have been in violation for so long.

5. Briefing by Republic on commercial containers.

Mike Reeves, wants to convert from sideload to front load. He conveyed that this will help our commercial businesses. It would save the customer money, because the containers would be bigger resulting in less pickups. The less pickups with benefit the city too by less road traffic and weight on existing streets. They will not be charging the customers to change their containers, they would just need space to keep the containers while they are switching them out. They would like to have this in place by the end of the first quarter.

Patricia Clifton, said her vote would be no because the current employee has only been here a short time, and the job has not been advertised for long. She stated the current employee agreed to the price, and so did Mrs. Holm for her position as Interim City Manager, but for the City Secretary position her answer is no. Mr. Wilson stated that if the council does it for one, they have to do it for both. Patricia Clifton said that the City Secretary job is a huge learning curve, and it's not on the same level as court.
