#### VI. Public Comments:

**David Nieto** – Mr. Nieto said he donates his time and money to the City and helps students with all kinds of things, including the bonfire; and yet, he feels like his wrecker service and that of others are being left out of the wrecker rotation. While copies were made of a new application submitted for the Building Standards Board, Mayor Garza entertained a motion to suspend the rules. A motion was made to suspend the rules by Council Member Kitley Wasicek, seconded by Council Member Pat Clifton. All in favor. Motion carried.

## 6. Discussion about Performance Evaluation of the City Manager.

Georgia Vines, City Manager, said that she has enjoyed her time in George West. The Council gave her positive reviews about all of the good changes that has transpired in the city since she became City Manager. She has encouraged and challenged employees to take advantage of the resources in education and certification, boosted our budget for financial stability, and her open door policy makes everyone feel welcome.

## 7. Discussion about annual performance reviews and merit increases.

Georgia Vines discussed a Cost of Living Adjustment (COLA) for employees. The federal government gave a 2% COLA, but we do not have to adhere to the same. They have never been given one, but the department heads gave a merit increases. Many good employees didn't get a raise or a few received a better increase. She believes we should set benchmarks for future merit increases and skills in which to measure. She plans on putting this together for future increases in salaries.

## 8. Consideration and Action to approve December 2017 Accounts Payable.

A motion was made to move as read by Council Member Kitley Wasicek, seconded by Mayor Pro-Tem Gerald Hardesty. All in favor. Motion carried.

# 5. Consideration and Action to appoint alternates to the Building Standards Board.

Mayor Garza entertained a motion to pull from the table Agenda Item #5 and reinstate the rules. A motion was made to move from the table Agenda Item #5 and to reinstate the rules by Council Member Kitley Wasicek, seconded by Council Member Pat Clifton. All in favor. Motion carried. Mayor Garza mentioned that the Building Standards Board needs to form the placement of members such as Place 1, Place 2, etc. This will help when discussing terms or changes. There was discussion concerning the terms per member. The Council voted by paper ballot on the selection of Robert White, Joe Ybanez, Merri Lee, and a new applicant, Randy Webster to the Building Standards Board. All in favor. Mayor Garza entertained a motion to amend Agenda Item #5 to read: Consideration and Action to continue the application process for two alternates to the Building Standards Board and furthermore, appoint Robert White for a term of three years; Joe Ybanez for a term of three years; Merri Lee, for a term of three years, and Randy Webster for a term of two years. Council Member Pat Clifton made a motion to amend, seconded by Mayor Pro-Tem Gerald Hardesty. All in favor. Amendment carried. Mayor Garza called for a vote and amended Agenda Item #5 passed.
