Special Session City Council Meeting Minutes - July 26, 2018

- I. The City Council met in Special Session with **Mayor Andrew Garza** calling he meeting to order at 7:00 P.M.
- II. Roll Call by City Secretary Maria Hernandez

Council Present: Mayor Andrew Garza, Mayor Pro Tem Jearl Rannefeld, Council Members Kitley Wasicek, Patricia Clifton, and Rindle Wilson. A quorum was present.

Staff Present: Maria Hernandez, Georgia Vines, Jason Lee, James Valadez, Noelia Martinez, Manuel Medina.

- III. Council Member Rindle Wilson gave the Invocation.
- IV. City Secretary Maria Hernandez led the Pledge of Allegiance to the United States Flag.
- V. City Secretary Maria Hernandez led the Pledge of Allegiance to the Texas Flag.
- VI. Public Comments were given by:

Mrs. Sandra Amoles

- Asked the following: Why are we having special meeting before having the regular meeting and why budget was not posted on the agenda.
- On June 18, Ms. Amoles sent a picture of the pool to the City Manager, addressing her consent on a manager level and she decided to share the information with lifeguard parents turning the situation into a sick pedophile issue. And because of that she had the parents making allegations. Someone in a professional position like Georgia needs to address city matters of concerns from the citizens in a professional way but instead she chose to instigate retaliation on the person who reported the concern of the city to her.
- She feels that Ms. Vines Slander her name
- She will file defamation of character lawsuit.
- Requesting the city council to do an evaluation on Georgia, due to the fact of lack of management in the vacancy of essential personnel.
- Requesting a copy of the evaluation and all documents, and if the council chooses not to evaluate her, she is requesting the council to vote no confidence on her
- If they fail to act on her request, Ms. Amoles will turn the case to the Texas Rangers to investigate.
- The only things positive the City Manager has done positive her eyes, is sale Cabanas and open the Pool, but without proper certifications.

- Ms. Amoles has been informed of city employees being remove or quitting due to false lies and allegations.

- First meeting to attend for Ms. Cisneros, Mayor explained how the public comments work.
- Directed comments to the comments before her.
- Ms. Cisneros does not feel the issue of the pool was taken out of any context or anybody trying to be slander. Ms. Amoles did that to herself.
- She is the mother of one of the lifeguards.
- The picture Ms. Amoles was sending was the picture of Ms. Cisneros daughter.
- A lot of parents were aware of the situation,
- Parents got together and new something was going on, people going by taking pictures of the city pool.
- She has people telling her to her face and via phone that they were sent to take picture of the Children. Trying to catch them doing wrong.
- Kids feel unsafe being at work
- She asked Ms. Amoles if she was going to continue to take pictures of the children? And that she was not comfortable of, Ms. Amoles taking pictures of the kids.
- Ms. Amoles said that she was advise and it was ok, and it was not against the law to take pictures. Since the children were hired if they were not comfortable with that, then they shall not be working there.
- Ms. Amoles is basically a town bully, she is instigating, her name and a lot of other names were brought up on the TOPIX website and a lot of awful things were said there.
- Ms. Georgia has done an awesome job getting the pool open, getting the kids certify, the children when through extensive training to do what they needed to do to be able to work there.
- If she needs to do anything in returned, filling motions or getting an attorney she will be glad to do so, because she is tired of the bullies in general.

Ms. Laura Gonzales

- Thanked Ms. Vines for the pool, it has been great, they used it every weekend.
- A positive thing here at George West, not many things for the kids to do, when they don't have things for them to do that is when they get in trouble.
- Everything has been positive that is what they need to see more.
- They teach the kids not to bully but when they see parents doing it that is not teaching them to do right.
- Ms. Vines has done good here at George West and Mr. Lee has done good She agrees with Ms. Cisneros on all she said
- Thanked Ms. Vines for the Pool and Officer Lee for all he has done for the kids.
- Hope to continue to work with George West and has talked to Ms. Kitley to bring more drug programs because is bad in the schools.
- If they need help with anything, she offers her help with anything.

Mrs. Grace Wilson

- Downtown Pots have been adopted.
- Fall Pride Cleanup Day Second week in October, will do it two weeks before Story fest. The last time the city provided a wonderful lunch, and this time is UTB to return the favor and provide lunch.
- The city did a fantastic job and money went go to open the pool she wants to see the same excitement for the downtown buildings to go away.
- Mrs. Wilson, called a Commercial Demo they are working in Live Oak county, he has provided four numbers for the survey that needs to be done first. He was concern of how unsafe the building is. He was afraid to walk on the side walk.

3. Discussion on continuing the processes for filling he positions of Public Works Director, Chief of Police, and Municipal Court Judge.

- City Manager has not gotten a qualify applicant, for Public Works
- Has been advertise in TML since August of last year, and has been advertise in the Progress, Beeville and San Antonio newspaper.

For Chief of Police:

- The Council has all the applications received for Police Chief. One withdrew his application.
- Council will take a vote and choose their top five applicants.
- After a brief discussion, three applicants were chosen.
- Attorney advised that first the council needs to decide what format they want to use, and also to consider breaking it up into two days.

- Interviews for police chief scheduled for Monday August 13, 2018 at 6:00 and 7:00 p.m. and August 14, 2018 at 6:00 p.m.

Public Works

- City Manager will call three rivers and asked where they advertise.
- Ms. Vines said that they want for the applicants to know the procedures.
- Can they hired somebody that can learn on the field?
- She also asked if they want to lower their standards?
- City Manager stated that the city needs to hire somebody that is qualify and know what needs to be done.
- Councilmember Clifton said that they need to go back to the original description and required that they have a license.
- Mayor: as the application are received for these positions, need to be forward to the council qualified or not, by Ms. Vines.
- City Attorney Mr. Valdez read the qualifications for Public Works Director, High School diploma, or GED, Texas driver license, Class C water license and a Class C waste water license. Shall be a resident of the city.
- Mayor-pro tem will put together a matrix that Ms. Vines will email to all the council members.

Municipal Court Judge

- 14,482 open cases
- The court is five legislative sessions behind, on forms on procedures, on policies, on fines. The citations had the incorrect information on it.
- The citations had not the correct information on it.
- Fees have not been updated in a long time.
- Mayor Garza said that there are several checks and money orders that were never deposit and that now are going to be sent to the comptroller's office.
- Ms. Grace Wilson asked how the court got this way? and said that the city needs help. She does know that the Mayor works long hours, but the court needs help.
- Mr. Walker, in the year past they had less than professional people in the court room.
- Mr. Valdez, said that when he stared working in the court, he belief that the court was beyond repair. But he has worked with three judges already and with several court clerks. The new clerk is excited and eager to learn, she needs to be train. The problem is that the city cannot keep people employed.

- Mr. Wilson said, that the city needs to hire a full-time judge for a year, to come and clear cases.
- Councilmember Clifton, said that she has not heard nothing but good things for Mayor Garza, but the City Charter requires to appoint a Municipal Court Judge.
- Mr. Valdez said that is the Council's duty to appoint a Municipal Court Judge.
- Ms. Cisneros commented that the Council needs to hire a Judge, the Mayor cannot be two people at once.
- Council decided, for the Mayor to continue as Judge until the November's audit.
- The court needs another clerk and needs to be very selective on the new court clerk.
- Mayor Garza asked City Secretary for her input. She said that the forms, fines and fees are wrong. She suggested for the city to hire a professional Court clerk to come and train the court clerk. The new court clerk has a lot of energy, smart and wants to make the court her career, the city needs to give her the tools and she will stay.
- Ms. Vines said that, the Municipal Court revenue is higher than the expenses.
- Mr. Garza said that "The only reward the he gets is that he is doing something that matters for the city he lives in, was born in and will die in."

4. Discussion on the Sewer Plant relining project.

- Ms. Vines stated, that the week before the council meeting clay samples were taken, and the test came out very good. She gave the test result to the Council. The surveyor is going in there to make sure the elevation is still the same, after the survey is done, the city is going out for bids and Ms. Vines hopes that within the next two months she has bids for the council, to accept or reject on the sewer plant repairs.
- Top soil and clay samples were tested, and Ms. Vines gave the council the results.
- The city is getting the clay from a local vendor who is also excavating and providing the clay for \$3 cubic yard for the clay including excavation.
- These meets all the standards of TCEQ. Samples were tested by a Rock Engineering.
- Ms. Clifton thank Ms. Vines for following through with these.

- This is a perfect example; this meeting has taken too long. After the form is completed the city Manager or City Secretary will turned in the form to all the city Councilmembers for review.
- This form will be emailed to all the councilmembers once all the necessary information has been completed this will allowed all the Councilmembers to ask any questions to the City Manager about the agenda item. Councilmembers are not to discuss any agenda item among themselves.
- Mr. Valdez said that the whole point of the meeting is for the Councilmembers to discuss items in front of everybody at the meeting. Mr. Valdez suggested to simplify the form, he also said that all the information is not needed.
- Councilmember Clifton said that she emailed the City Attorney, City Manager and Mayor to make sure they understand what she was asking.

- Ms. Vine asked for Councilmembers to email the City Secretary with items for the agenda. She has a folder where she puts items that will be put on future agendas.
