#### REGULAR SESSION CITY COUNCIL MEETING-October 18, 2018

- I. Mayor Andrew Garza called the meeting to order at 6:30 p.m.
- II. Roll Call by City Secretary Maria Hernandez
  Council Present: Mayor Andrew Garza, Mayor Pro-Tem Jearl Rannefeld, Council Members Kitley Wasicek, Patricia Clifton, and Rindle Wilson. A quorum was present.

- III. Invocation was given by Council Member Rindle Wilson
- IV. Pledge of Allegiance to the Flag of the United States was led by Maria Hernandez.
- V. Pledge of Allegiance to the Flag of Texas was led by Maria Hernandez.
- VI. Public Comments

**Debra Myers** – She states that she was employed with the City of George West from June 20, 2017 until June 27, 2018. She worked hard long hours. She was here to clarify a few things so there is no misrepresentation of her time as City Secretary. She states that she did not attend the July 19<sup>th</sup> council meeting but she reviewed it on Facebook. During her time in office, Georgia Vines appointed a committee to find the City three quotes for new medical insurance. She worked with an insurance broker named Tom Selzer. She states that at the July 19<sup>th</sup> council meeting Mrs. Vines stated that she was not paying \$2000.00 to her cousin. She continues by saying that she wants to set the record straight and that Mr. Selzer is not her cousin and has never been her cousin. She offers the council members his number so they could check the facts for themselves.

Secondly, she states that the City Manager posted on Facebook that Debra did not leave her passwords for the new City Secretary when she left. She states that she did

leave her password book in the left-hand draw of her desk and that there was only one person who knew that she left it there and that was Georgia Vines. Debra says she wanted to leave things convenient for Ms. Hernandez so she could get into the different programs and create her own passwords. Debra does not know what happened to the password book.

In the future she would like those who serve as public officials to check their facts before making statements to slander and defame another's name or make threats.

She states that she left her position due to personal reasons which also included working in a hostile environment that she could not change. She claims there was unethical hiring and firing practices along with lying and backstabbing displayed on a daily basis. She has seen and felt the intimidation at City Hall for herself and other employees.

Debra says her relationship with the Lord is first and foremost the most important aspect of her existence. It is because of that relationship that she works with integrity. She states that she was trusted to handle the responsibilities of her position in an honest, fair, and reputable manner and she took that role very seriously. She tried to demonstrate and act on qualities that would make the position and title respectable, as well as the citizens of George West, Proud. She wants to thank those who entrusted her with that honor and she appreciates the time she has been allowed to speak this evening to clear these things up.

Sandra Amoles – Sandra agrees with some of the things that Mrs. Debra Myers stated. She says that some of you guys need to act professionally on Facebook. Mrs. Pat Lancaster made a comment and she also made a comment to the newspaper and it makes her wonder how Pat is getting her information, is someone leaking out information?

She states that for those that took an Oath it's yall's job to be faithful to the citizens not to just take sides. She thinks that since Mrs. Vines has been here for 15 months that she has done some good but she thinks we deserve better.

She states that Mrs. Vines put her on blast for a picture she sent to Mrs. Vines that should have been a safety concern and she turned it into a sex pedophile.

She asks the council to be professional and states that Georgia posted something on Facebook that became a war about which streets need to be repaired. She claims that this Facebook post was Georgia's way of driving the Police Department and City Hall against the citizens of George West.

Sandra raises the question about the splashpad being a necessity over the repair of our streets.

Suzanne Martin – Suzanne says she is here tonight to make certain statements part of public record. She states that her name appeared on tonight's agenda as part of open session due to the City being notified there are two litigations brought to the City by her. She claims that her name appearing on the agenda is retaliation from Georgia Vines and Jason Lee. She is under advisement by her attorney to notify the City that an attempt to file a third charge for EEO for retaliation due to her name being listed on the agenda.

She states that a cease and desist letter has been sent by her attorney in regards to

Georgia Vines and Jason Lee. A defamation suit will be filed on her behalf against Georgia Vines and potentially Jason Lee will be forthcoming as soon as additional information is received to finalize the suit.

Suzanne is asking the council to vote tonight to terminate Georgia Vines and also asking Chief Perkins to terminate Jason Lee.

Ray Harris – Mr. Harris hands out papers that pertain to his reason for being here. He states that he is there tonight to state why he thinks certain employees should not be fired and that these thoughts are his own and not enforced on him from anyone else.

Rodney Wilson – He wants to make a few comments on the ongoing investigation of the misuse of taxpayer money by previous administration. He states that it is his understanding that over the past year or year and a half that the Attorney General office has sent two emails requesting copies of five cancelled checks and that those emails have been ignored. He wonders why these emails were ignore for so long and that it took our City Attorney Mr. Valdez, one afternoon to find four of those five missing checks.

Mr. Wilson states that he feels that the council sees taxpayer money as monopoly money and there is no accountability for these actions. City Attorney Carlos Valdez says that Shirley Holm needs the credit for finding those checks. Georgia Vines says that she asked Mrs. Holm to look for those checks and that she said she will look for them when she had the time. Shirley Holm says that she did contact the bank and because of the date they were not able to give her the cancelled checks. She also states that she did go into the storage room to look for those checks but felt unsafe with moving boxes with the height and number of unstable boxes at the time.

**Ray Lopez** – Ray is requesting to move his barbeque food trailer to in front of the Buck West House.
