I. The City Council met in Regular Session with Mayor Andrew Garza, calling the meeting to order at 7:00 p.m.

- IV. Interim City Secretary D'Ann Lane, led the Pledge of Allegiance to the United States flag.

Public Comments were made by Mrs. Grace Wilson, she thanked the council for approving the cleanup day. It was the biggest turnout the city has ever had, and everyone worked together.

- VII. Announcements and Correspondence
 - a) Mayor Garza, added that we ran out of bins for cleanup day. It was a huge

success, we were right at about 150 loads, and about 5 full open top trash containers.

b) Council member Patricia Clifton, added that the last Sunday, in April is called Blue Sunday. Blue Sunday, is where people wear blue to honor neglected and abused children.

CONSENT AGENDA:

Mayor Andrew Garza, asked if anything needed to be pulled from the consent agenda. Nothing was pulled. Mayor Garza, called for a vote. All in favor. Motion Carried and consent agenda was approved.

PRESENTATIONS:

3. PowerPoint presentation by Armstrong, Vaughan, Associates, P.C. for the City of George West FY 2017-2018 Audit.

The auditor gave a detailed report on the 2017-2018 FY. Every year the city has improved significantly. In the governmental activities the city's assets exceeded its liabilities by \$704 thousand. The city's net position decreased by \$740 thousand primarily due to lower ticket revenue. Business type activities assets of the Water and Sewer Fund exceeded its liabilities by \$2.7 million at September 30, 2018. Unrestricted net position increased \$261 thousand to \$2.74 million at September 30, 2018. The General Fund's fund balance at the end of 2018 fiscal year was \$232 thousand and the combined fund balance for all funds was \$899.5 thousand. Fund balance for the general fund decreased \$80 thousand. The decrease is the result of lower revenues from municipal court tickets. She also gave other recommendations on what the city should do in preparation for the audit next year.

4. Engineer's Report by LNV

At the last meeting LNV was tasked with getting Bath Engineering out here to test our current SCADA system. They came out and looked at all the components, and determined the connections can be reused. The membrane of the system will have to be replaced, it was originally installed in 2000. Getting the original company out here to fix the system would be difficult. LNV, had a proposal from Mercer Controls \$74,485. Two more proposals came in since the last meeting. A bid came in from Control Networks

Plus in the amount of \$49,712. The last bid that came in was from C.W. Cambell Electric, Inc. for \$132,000. Control Networks Plus, uses a cell phone system to control the SCADA. Mercer Controls was using an antenna system. And Mercer, was also using a radio network. Grady, explained what each bids contained and what they come with, he also went into detail about the new cell phone system since it's a new system. Grady, informed the council that Mr. Higgins, now wants to go with Control Networks Plus.

Move as read by Jearl Rannefeld, seconded by Rindle Wilson. Open for discussion. Mayor Garza, called for a vote. All in favor. Amendment carried.

Move as read by Patricia Clifton, seconded by Rindle Wilson. Open for discussion. Shirley Holm, explained that having a rotating schedule on council members to sign check and accounts payable would make it easier so the city is not calling the same person every week.

Consideration and Action to open the Cactus Park Swimming Pool for pool parties beginning on: May 20, 2019, from 6:00-9:00 p.m; Memorial Day Weekend, May 25 10:00-6:00 p.m., May 26 1:00 p.m.-5:00 p.m., and May 27 10:00 a.m.-6:00 p.m; regular summer hours beginning June 1, 2019, Tuesday-Saturday 10:00 a.m.-6:00 p.m. and Sunday from 1:00 p.m.-5:00 p.m.

Move as read by Patricia Clifton, seconded by Kitley Wasicek. Open for discussion. Shirley Holm, updated the council on when the pool would be ready to open. She also explained why she would like to open the last week of school for pool parties. Mayor Garza, called for a vote. All in favor. Motion Carried.
